



## KARRAN ACRYLIC SINKS LIMITED 30-YEAR WARRANTY

Plexicor (USA) Inc., (hereto known as the Company) warrants each new solid surface integral undermount sink to be free from defects in workmanship and materials when used under normal conditions and maintained properly. This warranty applies to any Karran solid surface / acrylic integral undermount sink but does not apply to damages caused by the following:

1. Accidents, physical abuse or misuse
2. Damage from heat
3. Breakage not due to a defect in the manufacture of the material
4. Improper care and maintenance
5. The alteration or repair of any Karran product by anyone who is not authorized by the company in writing

The warranty shall be in effect for a period of 30 years from the date of installation into the residential or commercial application. This shall be instead of any other warranty, either express or implied, including but not limited to, any implied warranty of merchantability or fitness for a particular purpose. The only company providing this warranty is Plexicor (USA) Inc. and no distributor or retailer is providing any warranty, either express or implied. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

The Company will repair or replace, at its option, any Karran solid surface / acrylic integral undermount sink that the Company has found to contain a manufacturing defect and is within the period of the warranty.

The Company reserves the right to examine the product in question and its installation prior to replacement. Product replacement does not include transportation cost or labor installation charges. The Company reserves the right to substitute an equivalent model at its sole discretion.

The liability of the Company, under this warranty, is limited solely to the repair or replacement of the Karran solid surface sink within the warranty period. Should the sink, at the company's option, be replaced, the Company shall provide \$300 (three hundred dollars) only towards the installation of another Karran solid surface sink. Should the sink needing replacement be undermounted in a solid surface or stone top, the replacement sink may be an undermount sink. Should the sink needing replacement be undermounted in a laminate top, the replacement sink will be a Karran top mount sink. The Company shall not be liable, under any circumstances, for consequential or incidental damages, including, but not limited to, personal injury or labor costs in excess of \$300 (three hundred dollars) per sink. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. This warranty gives the original purchaser specific legal rights and you may have other rights that vary from state to state.



Under no circumstances will the Company be responsible for any expense in connection with any repairs made by anyone other than an authorized representative of the Company and Karran solid surface products. All repairs must be specifically authorized by the Company in writing before being undertaken.

Please Note: Your sink is automatically warranted. You are not required to submit any warranty or purchase information to the Company.

In the event of a warranty claim, the owner will be required to write to the address below, including a letter with the following information:

- Description and nature of the defect
- Date of purchase and installation with a copy of the original purchase receipt
- Model number or description of model
